

# Terms and Conditions

## St James Quarter Opening - Rental Giveaway 2024 (“Giveaway”)

### **Full Terms and Conditions:**

1. This Giveaway is open to entrants aged 25 or over who are resident in the UK, excluding families of the Promoter, agents or anyone else professionally connected with the administration of this Giveaway (“**Entrants**”)
2. The Promoter of this Giveaway is Europcar Group UK Limited of 1 Great Central Square, Leicester, LE1 4JS, UK (the “**Promoter**”)
3. The Giveaway is free to enter and no purchase is necessary. However a valid email address, postal address and telephone number are required.

### **Promotion Period:**

4. The Giveaway will run from 9am GMT on 27 April 2024 up to 11.59pm GMT on 04 May 2024 (“**Promotion Period**”).
5. All entries must be received by the end of the Promotion Period to be valid and no liability is accepted for illegible, incomplete or late entries. All entries received after the end of the Promotion Period will not be valid.
6. Maximum of one entry per person is permitted during the Promotion Period. Any further entries submitted during the Promotion Period will not be accepted and will be automatically disqualified.

### **To Enter:**

7. All entries must be submitted by completing and submitting the online entry form, providing complete responses to all required fields.

### **The Prize:**

8. The winner will receive a 7 day free hire of an MG4 (“**Vehicle**”)
9. Free rental includes: Damage Liability Waiver (subject to a £1,000 excess for which a credit or debit card will be needed), Theft Waiver, road tax, VAT, but excludes the cost of charging the Vehicle and any additional excess waivers that the winner elects to add. It is the winner’s responsibility to ensure that they are covered to drive the Vehicle to the locations and for the uses they intend and for the entire free rental period.
10. The prize is only available on the UK mainland for pick from selected Europcar branches – nearest will be advised to the winner upon notification of address.
11. The prize must be taken before 24 December 2024

12. Prize Draw: On 6th May 2024, 1 winner will be selected at random by a computer process from the list of Entrants' data collected from the Giveaway entry form.
13. The winner will be informed of the exact details of their free car rental once they have been selected and been given the winner notification.
